## Release of Information

Thank you for your correspondence of 4 August 2022 in which you requested the following information:

'Please could you give the number of personnel with every rank (comissioned and "other rank") in the Royal Marines in each year 2000-2022 (inclusive)?'

Your enquiry has been considered to be a request for information in accordance with the Freedom of Information Act 2000 (the Act).

A search has been completed within the Ministry of Defence (MOD) and I can confirm that information in scope of your request is held. However, in considering your request, it has been determined that some of the information you have requested falls under the qualified exemption at section 26 (Defence) of the Act.

Under s26(1)(b) information is exempt if its disclosure under the Act would, or would be likely to, prejudice the capability, effectiveness or security of any relevant forces.

As section 26 is a qualified exemption, it has been necessary to conduct a Public Interest Test to assess whether release of the information would, or would be likely to, prejudice the effectiveness and capability of our Armed Forces. This has now been conducted and I can advise that after careful consideration of the information and for the reasons detailed below, the balance of public interest was found to be in favour of withholding the detailed breakdown of Royal Marine (RM) ranks both Officer and Other Ranks for each year from 2000 to 2022.

It is accepted that there is a public interest in the current and future capabilities of the RM, and release of the information would provide assurance that the RM are resourced appropriately to enable them to deliver their Defence objectives. However, there is also a compelling interest in ensuring that the security and effectiveness of our Armed Forces is not compromised by the release of this information. Due to the small numbers in the RM, it would be easy to determine patterns in strength over that period of time which could be used to derive tactical level information on current and future operational capabilities of the Armed Forces resulting in the information being used to degrade and disrupt important elements of RM duties.

What I can provide is the total annual number of RM Officers and Other Ranks for the period 2000-2022. This information is enclosed at Annex A to this letter.
