## Information Request: FR7138a

Thank you for your Freedom of Information request dated 2<sup>nd</sup> March 2017. Your request has been dealt with under the Freedom of Information Act and is detailed below in italics.

## **Our Response**

The Freedom of Information Team has been provided with the following information in response to your recent request on behalf of Northamptonshire County Council (NCC).

Following receipt of the project management governance arrangements for the allocation of the Growth Deal Funding for A43 phase 2. Roundhill Northampton Ltd, the option holder on land E and W of the A43 North of Moulton, requests a breakdown of the Growth Deal funds spent to date and a budget of the proposed allocation of the remaining Growth Deal funds.

Please find attached the breakdown of expenditure for A43 Phase 2 submitted alongside the Highlight and Claim report attached to the response to FR7138.

The budget for the allocation of the Growth Deal funds can be found in the attached Project Initiation Document submitted to the County Council's Capital Investment Board and approved by the County Council's Cabinet in September 2016.

Below is an extract from the confirming that NCC's Highway team is managing the scheme. And the NEP (SEMLEP) is providing scheme governance

"The scheme will be managed by Northamptonshire County Council's Highway team, a partnership between the County Council and Kier-WSP, with a designated project manager, etc. Construction will be tendered, probably using the Midlands Highways Alliance framework.
