Thank you for your Freedom of Information request received on 25th March 2015. You asked:

It was however last updated in December 2013. Please could you send me a copy of the latest list?

Please also provide a list of subcontractors to the prime providers for Community Work Placements."

The link (posted above) links to the latest published information on Work Programme supply chains. DWP are currently in the process of updating this information and updated data relating to a snapshot of sub-contractors will be published in due course.

To provide a list of sub-contractors now as specified we estimate that the cost of complying with your request would exceed the appropriate limit of £600. The appropriate limit has been specified in regulations and for central Government it is set at £600. This represents the estimated cost of one person spending 3½ working days in determining whether the Department holds the information, and locating, retrieving and extracting the information. Under section 12 of the Freedom of Information Act the Department is not obliged to comply with your request and we will not be processing your this part of your request.

A list of Community Work Placement subcontractors can be found at Annex 1 in this letter.
