Freedom of Information Request – Interim Response

Thank you for your recent request for information, received 15 February 2017, made under the Freedom of Information Act 2000 (the Act). You requested the following:

- Can you please send me 10 O Level and 10 A Level Biology papers and 10 O level and 10 A Level Chemistry papers from between 1970-1980?
- Can you please send me 10 O-level and 10 A Level Biology and 10 O level and A level Chemistry papers from 1980-1990.
- Can you please send me any AQA and/or OCR A level Biology and Chemistry papers you have from 1990-2000?

Under the Act, public authorities have two duties to individuals requesting information: firstly, to confirm whether or not they hold the information requested, and secondly to provide a copy of that information unless one or more of the exemptions under the Act apply.

I can confirm that we do not hold the information requested on site. I have requested files from our archives but this is taking more time than expected and so we will not be able to fully respond within the expected timescale. This type of document is not something which Ofqual would normally retain and any we may have are likely to be legacy documents from our predecessors QCA/QCDA.

To assist you in your request it may be more fruitful to contact the Awarding Organisations involved in General Qualifications (GCSEs and A Levels) as they should have the records you are seeking. For ease, I have listed their web addresses and contact email address below.
