Unfortunately, we cannot disclose the names of the Heads of Service, Area Managers/Service Managers, Team Managers/Team Leaders, within Children Services. As these officers are not a Senior officers in the organisation this information is exempt by virtue of Section 40 (2) of the Freedom of Information Act 2000. Disclosure of this information would breach Principle (a) of the GDPR. This is because disclosure would be unfair to those people who could be identified from the information who have no expectation that their personal data would be made public.

This letter therefore acts as a refusal notice in accordance with Section 17 of the Freedom of Information Act 2000 in respect of the above.

If you are dissatisfied with the handling of your request, you have the right to ask for an internal review. Internal review requests should be submitted within two months of the date of receipt of the response to your original letter and should be addressed to:
