

1 Introduction

1.1 Citation

Arcadis does not accept any responsibility for the accuracy of any documents provided by others, nor do we have any liability or responsibility for the design of future projects, specification of materials or methods of construction.

The file has been designed to alert those who are responsible for the property to potential risks and hazards that must be managed when the site is further developed. It is a record of information to influence future decisions on the management of health and safety in connection with persons at work in or on the site or of any person who may be affected by the work of such persons.

As such the file must be kept available for the benefit of those involved in future construction projects and maintenance activities. It will form the major part of information be made available by the client during the planning stages of future works and should also be made available to the Principal Designer/Principal Contractor on any future projects.

Future Duty Holders will be responsible for ensuring that the necessary additions and amendments are made. The format of the file has been designed with this in mind, the Register of CDM Works having been provided to ensure that the development of the File is adequately recorded by the Principal Contractor concerned.

1.2 Advice to Client

2 Project Information


The project was Stage/Phase 1 of various planned works around Lichfield.

2.1 Project Description

Stage (1) of the Lichfield council work was for the demolition of the two semi-detached properties at 18-20 Frog Lane and the nearby empty Tempest Ford garage at the junction of St John Street and Birmingham Road near the centre of Lichfield. The project was to take the buildings down to ground floor level and did not include the grubbing up of the foundations, redundant and reportedly concreted fuel tanks. The fuel interceptor was not removed or disturbed either

2.2 Location of the Project

The sites are situated on Frog Lane for the Semi-Detached houses and St John Street/Birmingham Road for the Tempest Ford Garage.


