Section 40(2) together with the condition in section 40(3)(a)(i) provides an absolute exemption if disclosure of the personal data would breach any of the data protection principles.

Personal data means data which relate to a living individual who can be identified-

- (a) from those data, or
- (b) from those data and other information which is in the possession of, or is likely to come into the possession of, the data controller or any other person in respect of the individual.

Information will "relate to" a person if it is about them, linked to them, has some biographical significance for them, is used to inform decisions affecting them, has them as its main focus or impacts on them in any way. The information redacted in this document, if released, would breach the 1<sup>st</sup> principle of the Data Protection Act 1998 which states that personal data shall be processed fairly and lawfully.
