Plesase note, the MSc Robotics & Artificial Intelligence programme began in academic session 2020/2021, therefore the University does not hold data for admission cycles 2018/19 or 2019/20. Additionally, the admission cycle for 2021/22 is still ongoing; the data above is a current snapshot and will continue to change until the start of academic session 2021/22, in September 2021. The University cannot provide enrolment data for session 2021/22 as enrolment will not begin until August 2021. Therefore, The University of Glasgow does not hold all of the information that you have requested and is not aware of any other public

authority that could respond to your request. Section 17 of FOISA states that where public authorities receive requests for information that they do not hold, they must issue a notice advising that they do not hold the requested information.

The supply of documents under the terms of the Freedom of Information (Scotland) Act 2002 does not give the applicant or whoever receives the information any right to re-use it in such a way that might infringe the Copyright, Designs and Patents Act 1988 (for example, by making multiple copies, publishing or otherwise distributing the information to other individuals and the public). The Freedom of Information (Scotland) Act 2002 (Consequential Modifications) Order 2004 ensured that Section 50 of the Copyright, Designs and Patents Act 1988 ("CDPA") applies to the Freedom of Information (Scotland) Act 2002 ("FOISA").

Your right to seek a review

Should you be dissatisfied with the way in which the University has dealt with your request, you have the right to require us to review our actions and decisions. Your request must be in a recordable format (letter, email, audio tape, etc). As the University of Glasgow is a Scottish Public Authority, your request is subject to the terms of the Freedom of Information (Scotland) Act 2002 ("FOISA"). The Coronavirus (Scotland) Act 2020 provides for an extension to the normal timescale for response to FOI requests for review to 60 working days from receipt of a request. You will receive a full response to your request for review within 60 working days of its receipt.

If you are dissatisfied with the way in which we have handled your request for review you may ask the Scottish Information Commissioner to review our decision. You must submit your complaint to the Commissioner within 6 months of receiving the response to review letter. The Commissioner's Office may be contacted as follows:
