From the 2017 to 2021 cycles, the number of applicants, offers, and acceptances. Also, the median range of number of A*/8-9 grades achieved at GCSE, and the median A level predicted grades held by applicants and offer holders for each of these years.

I would like this data to be sorted by home and international applicants.

I would like to clarify that I am requesting the median number of GCSE A*s/8-9s for both applicants and offer holders.

Clarification:

I understand that it would be too cumbersome to send A level and GCSE median grades, so there is no need to send that data.

Please send only the number of applicants, offers, and acceptances for the MEng and BSc Computer Science Courses from the 2017 to 2021 cycles, and please sort this data by home and international applicants.
