### Request for information under the Freedom of Information Act 2000 ("the Act")

Further to your recent request for information held by King's College London, I am writing to confirm that the requested information is held by the university.

### Your request

We received your information request on 19 December 2019 and have treated it as a request for information made under section 1(1) of the Act.

You requested the following information:

#### *Acceptances*

*The total number of applicants for the M100 course; The total number of offer holders for the M100 course; The offer rate for the M100 course;*

- The percentage of offer holders who chose your university's M100 course as their firm choice on UCAS;*
- The percentage of offer holders who chose your university's M100 course as their insurance choice on UCAS*
- The total number of offer holders who met or exceeded their offer;*
- The total number of offer holders who missed their offer;*
- The number of offer holders who missed their offer in some way, but who were still offered a place on results day.*
- The number of offer holders who missed their offer in some way, but who were still offered a place on results day if they did not possess the contextual offer of AAB, but rather the typical offer of A\*AA.*

- The number of offer holders possessing A\*AA contextual offers who missed their offer in some way, but who were still offered a place on results day along with the number broken down into respective A Levels grades, for example A\*A\*B or AAA.
