With Self-Directed Support (SDS) a person can spend their budget on anything that meets the identified outcomes on their social care assessment, as long as it is legal and not a Health responsibility.

Prior to SDS a person could use their ILF on provision such as domestic support, which the LA did not provide. Detail of ILF provision should be available from ILF: <http://www.dwp.gov.uk/ilf/>.

When recorded, ILF funding is attached to a client not a specific service or care package. ILF will only fund after a certain level of LA funding has been reached (the level has varied over the years).
