HS2: Phase One Safeguarding Directions

Action

1. DfT announced in a Written Ministerial Statement¹ on 9 July 2013 the publication of the decisions on safeguarding provisions for Phase One of HS2, which protects the proposed route from London to Birmingham from future development which might conflict with the planned high speed line. The latest version of the direction² was announced via a Written Ministerial Statement³ on 26 June 2014, which revises the previous directions issued in October 2013⁴ to more closely match the description of the scheme, as set out in the HS2 hybrid Bill, currently before Parliament. Inspectors will need to be aware of the implications of the revised directions for proposed developments in designated safeguarding areas as well as any preparation of amended Local Plan documents or those under examination, together with the additional consultation requirements (see Paragraph 4 below) for the affected LPAs at application stage (listed in the Annex).

Background

2. Following the outcome of the DfT consultation between October 2012 and January 2013 on issuing safeguarding directions, the SoS announced directions⁵ to protect the proposed HS2 Phase One route from London Euston to the West Midlands (with a new station in central Birmingham) from conflicting development before the construction starts. The directions came into force on 9 July 2013

under articles 16(4), 25(1) and 29(6) of the Development Management Procedure Order 2010 (DMPO)⁶. The directions ensure that new developments along the route corridor do not impact on the ability to build or operate HS2 or lead to large additional costs.

- 3. The SoS decided to issue the directions in two stages, Stage A directions issued on 9 July 2013 include all the proposed phase one route except for the sections relating to the proposed tunnel through Ealing & Northolt and the Bromford Viaduct Tunnel, which were subject to Stage B directions issued in October 2013, following the outcome of a consultation launched in May 2013. On 26 June 2014, the directions were revised and replaced with an updated set of safeguarding directions, which broadly reflect the land requirements set out in the hybrid Bill⁷, currently at committee stage in the House of Commons, which will confer powers to construct phase one of the HS2 scheme from London Euston to Birmingham Curzon Street.
- 4. i) Planning applications LPAs to whom safeguarding directions apply are required to consult High Speed Two (HS2) Ltd on any future and currently undetermined or pending planning applications as at 26 June 2014 (with certain exemptions). LPAs should review all pending applications to assess if proposed developments are subject to the revised safeguarding directions. If the LPA is minded to grant permission contrary to comments received by HS2 Ltd, the SoS will determine the application. However, if HS2 Ltd do not respond to the consultation within the time specified by article 16(5) of the DMPO the LPA can determine the application. If permission is refused due to conflict with HS2, the decision notice should include this reason.
 - ii) Local Plans when preparing any local plan document any relevant designated areas should be identified in the amended Local Plan; directions should be indicated on the policies map; proposals should not include policies which conflict with the safeguarding direction. Where the Local Plan has been submitted for examination the LPA should record any relevant correspondence and bring this to the attention of the Inspector.
 - iii) Blight and Purchase Notices the provisions of the $1990~{\rm Act}^8$ on blight and purchase notices will apply to property affected by the safeguarding.

5. HS2 Updates:

i) The High Speed Rail (Preparation) Act 2013, gained royal assent on 21 November 2013, which makes provisions authorising

expenditure in preparation for HS2 to enable the project to proceed without delay.

- ii) Public Consultation on the <u>proposed route for HS2 Phase Two</u> was launched on 17 July 2013⁹ and ran for 6 months until January 2014. Phase Two will provide a high speed line from the West Midlands to Manchester and Leeds, with connections to the West and East Coast Main Lines, serving the rest of the North of England and Scotland. The outcome of the consultation is awaited.
- iii) Other recent HS2 consultations include HS2 property consultation 2014¹⁰, which seeks views on policies for owner-occupiers of properties close to the HS2 phase one route and HS2 Phase One environmental statement consultation¹¹, which sought views on the final environmental statement accompanying the hybrid Bill.
