Dear Andrew Partridge

I refer to your request where you asked:

"Please provide under the FOI Act all Cabinet Office advice to Ministers, including the Prime Minister and Secretary of State for Justice, about the transfer of responsibility for FOI from the Ministry of Justice to the Cabinet Office."

I am writing to advise you that following a search of our paper and electronic records, I have established that the information you requested is held by the Cabinet Office.

The information is exempt under sections 35(1)(a) of the Freedom of Information (FOI) Act as it relates to the formulation and development of government policy. The disclosure of this information at the current time would have adversely affected the ability of officials to provide detailed advice on this issue, and would harm the ability of officials and ministers to discuss the merits of particular steps.

In line with the terms of this exemption in the FoI Act, we have considered whether it would be in the public interest for us to provide you with the information, despite the exemption being engaged.

There is a public interest in understanding the working and decision making process of the government and an accountability to provide assurance that the decision was taken on the basis of a full assessment of the benefits and risks associated with a change of this type. These public interests have to be weighed against a strong public interest that policy-making and its implementation are of the highest quality and informed by a full consideration of all the options.

Ministers and officials must be able to discuss policy freely and frankly, exchange views on available options and understand their possible implications. The candour of all involved would be affected by their assessment of whether the content of the discussions will be disclosed prematurely. The loss of the ability to have full discussions on the basis of such advice would damage the quality of decision making and lead to an adverse impact on the effective operation of government.

At the current time, having considered the circumstances of this case, I have reached the view that the public interest favours withholding this information under sections 35(1)(a) of the FOI Act.
