Thank you for your Freedom of Information request received on 20th February 2018. You asked for:-

I would like to request aggregated counts of individuals registered with a National Insurance Number under the Social Security Act 1948 for 2011 from the DWP Customer Information System. I would like this information in a table format with counts of individuals in each Datazone in Scotland (2001 boundaries), based up postcode, by 5 year age groups (16-29, 30-44, etc). As these would be aggregated counts of the population, there does not need to be any disclosure on confidential information such as name, postcode etc. If numbers would become so small that data is made identifiable for older age groups, counts can be for a 65+ age band.

DWP Response:

The Customer Information System does hold information for individuals who have registered for a National Insurance Number, however the information requested is not readily available and a scan would need to be commissioned to obtain the information and output in the requested format. The cost of commissioning a scan to obtain the information requested would exceed the appropriate limit therefore we are unable to comply with this request.

The appropriate limit has been specified in regulations and for central Government is set at £600. This represents the estimated costs of one person spending 3.5 working days in determining whether the Departments hold the information, and locating, retrieving and extracting the information.

Under section 12 of the Freedom of Information Act the Department is not obliged to comply with your request.

Under section 16 of the Freedom of Information Act, we should assist you with your request so that it may fall beneath the cost limit. However, in this instance narrowing your search is likely to produce the same results as, for example, obtaining the volume of National Insurance Number Records held on the Customer Information System in 2010 alone would require a bespoke scan to be commissioned which would exceed the appropriate limit.

We will consider afresh any revised request however we cannot guarantee that any revised request will fall within the cost limit.
