# RE: Request for Information - RFI3299

Thank you for your recent email of 21 January 2021, which was submitted as Freedom of Information Act 2000 (FOIA) request through the 'What do they know' website.

### Request

Me and my wife are trying to complete the sale of our house, which was purchased in October 2015 using the HTB equity loan scheme.

A restriction on the title is preventing our solicitor from completing the sale.


We therefore need to receive a copy of the agreement dated 11 February 2010 between the Homes and Communities Agency, Kier Ventures Limited and Kier Limited, so that our solicitor can certify that clauses 5.14.1 and 5.15 of said agreement have been complied with or do not apply.

(04.02.2016) RESTRICTION: No disposition of the registered estate by the proprietor of the registered estate, or by the proprietor of any registered charge, not being a charge registered before the entry of 1 of 2 B: Proprietorship Register continued this restriction, is to be registered without a certificate signed by a conveyancer that the provisions of clause 5.14.1 and 5.15 of an Agreement dated 11 February 2010 and made between (1) Homes and Communities Agency (2) Kier Ventures Limited and (3) Kier Limited have been complied with or that they do not apply to the disposition

#### Response
