## FREEDOM OF INFORMATION REQUEST: ARM'S LENGTH FOUNDATION

In response to your FOI request of 23 September on Arm's Length Foundation, please find the response of Glasgow Clyde College as below:

The Glasgow Clyde Education Foundation is an independent charity (Scottish Charitable Incorporated Organisation No. SCO44616) which is a separate entity from Glasgow Clyde College. For that reason I am unable to provide details of remuneration, annual sums and pension premiums paid to trustees/members of the Foundation as the college does not hold that information.

Similarly, the college does not hold the information concerning officers and staff employed by the Foundation.

With respect to your specific questions, the responses are as follows;

- In relation to donations to the Foundation. Glasgow Clyde College has made two donations to the Foundation; £14.4million in March 2014 and £600,000 in March 2015.
- 2. The college does not hold this data.
- 3. I can confirm that the minutes of Board meetings and AGM are shared with the college through its membership of the Board of Trustees of the Foundation. However I consider that this information is exempt from disclosure under section 36(2) of FOISA insofar as the information was obtained by the college from a third party and its disclosure would constitute an actionable breach of confidence.
