You may also find the following lines useful in relation to the NPPF / planning system that we used for a different MSU:

The National Planning Policy Framework expects local authorities, whenever relevant, to take account of the benefits of the best and most versatile farmland, to enhance biodiversity, and to recognise the character and beauty of the countryside. The Framework also includes rigorous protection for Green Belt, National Parks, Areas of Outstanding Natural Beauty and other designated rural land. We have also been very clear that a planning application for a renewable energy development should only be approved if the impact is, or can be made, acceptable. Where a proposal involves greenfield land, local authorities are expected to consider whether the proposed use of any agricultural land has been shown to be necessary and where high quality agricultural land is involved this would need to be justified by the most compelling evidence. Finally, we have been clear that the need for renewable energy does not automatically override environmental protections and the planning concerns of local communities and the views of local communities should be listened to.
