I attach the updated Site Layout Plan (drawing 4732-PL-02 Rev C) discussed by telephone.

This is identical to Rev B except for the widened carriageway shown in front of the site in Barrack Street. A widened carriageway was annotated on Rev B but the drawing showed the relevant land as verge rather than carriageway. Rev C corrects this discrepancy and allows for a minimum 4.8m carriageway and a 2m grass verge in front of the site.

This is consistent with what was shown on the original layout plan in this regard.
