Hi Becky,

From my site visit (peering into site from the road) and initial desk-based study, this site looks to have some very well preserved ridge and furrow. The multi orientated layout, and clear pre-enclosure land division makes it an important site in terms of these rapidly dwindling earthworks. I have attached a screen shot for your records.

We would be minded to recommend that this proposal is not progressed. With ridge and furrow, we often recommend moving areas of impact to the edge or to a different part of the site, but in this case the whole farm looks really well preserved, and it is the relationship of all the small areas which adds to its significance. We would therefore prefer that none of it is destroyed.
