**FREEDOM OF INFORMATION REQUEST - RESPONSE**  
**FOI Reference: OPTUM FOI 500-673 – SWL CCG**

I refer to your email received on 13 August 2019. I can confirm on behalf of NHS South West Lincolnshire Clinical Commissioning Groups (CCG) supported by Optum Commissioning Support Services, and in accordance with S.1 (1) of the Freedom of Information Act 2000 (FOIA) that we do hold the information you have requested. A response to each element of your request is detailed below:

**REQUEST & RESPONSE**

- 1.0 Please can you give me the information for the last five years regarding the annual spend on rehabilitation services procured via private companies for Lincolnshire patients?

I would like to know the break down by spend on

- Major Trauma Patients
- MSK Patients
- Neuro Rehab Patients
- Amputee Patients
- Stroke Patients

**RESPONSE:**

From the CCG's perspective, the only patient group that might go to a Private Provider would be Neuro Rehab. All other patients should all be able to access NHS services.

Table 1 in Appendix 1 details the amount spent on Neuro-Rehab by the CCG.

- 2.0 I would also like to know with which private providers these purchases have been made,

**RESPONSE:**

All expenditure is with private providers.

- 3.0 I would also like to know how many patients are sent to each company

**RESPONSE:**

This information is not held by the CCG. This information is not identified on the CCG's Ledger.

- 4.0 Could you then confirm whether there will be any provision to bring all of this rehabilitation work back into an NHS provider in the future?

**RESPONSE:**

Where appropriate NHS provision exists, local or otherwise, the CCG would seek to use NHS Services.

I trust that this answers your queries with the information we currently hold, but if we can be of any further assistance please do not hesitate to contact the FOI Team.
