I have answered each of your questions separately below.

*'What are the contractual performance KPI's for this contract?'*

There are no contractual KPIs for this contract.

*'Has a decision been made yet on whether the framework(s)/contract(s) are being either extended or renewed'*


This is a works contract therefore this is not applicable.
