Thank you for your request for information regarding Annual Reports & Budgets which has now been considered.

Applicant Question:

Please provide all Annual Reports and Budgets of the NPCC since its founding.

NPCC Response:

Section 17 of the Freedom of Information Act 2000 requires the NPCC, when refusing to provide information by way of exemption in question and (c) states why the exemption applies. In accordance with the Freedom of Information Act 2000 this letter acts as a refusal notice to those aspects of your request.

Section 40 Personal Information - the legislation

- (1) Any information to which a request for information relates is exempt information if it constitutes personal data of which the applicant is the data subject.
- (2) Any information to which a request for information relates is also exemption if-
 - (a) It constitutes personal data which do not fall within subsection (1), and
 - (b) Either the first, second or third condition is satisfied

Section 40 is an absolute exemption and there is no requirement for me to conduct a public interest test.

The NPCC does not hold annual reports. There is no singular 'annual' report(s) for any area of NPCC business.
