# Your Right to Request a Review of Decisions Made Under the Terms of the Freedom of Information Act (2000).

#### Ask Norfolk Constabulary to look at the decision again.

If you are dissatisfied with the decision made by Norfolk Constabulary under the Freedom of Information Act (2000), regarding access to information, you must notify Norfolk Constabulary that you are requesting a review within 20 days of the date of its response to your Freedom of Information request.
