Request for information under the Freedom of Information Act 2000 ("the Act")

Further to your recent request for information held by King's College London, I am writing to confirm that the requested information is held by the university.

Your request

We received your information request on 7th February 2020 and have treated it as a request for information made under section 1(1) of the Act.

You requested the following information:

In accordance with the Freedom of Information Act, I would like to request the following information regarding admissions to all Undergraduate courses.

For the time range spanning from 2009 to 2019:

- 1) Number of applicants across all undergraduate courses*
- 2) Number of acceptances across all undergraduate courses*

Our response

Please find a table below outlining the numbers:

UCAS Cycle

Acceptances	5635	6367	7604	8531	8602	9117	9996	11445

Caveats below:

- Data is taken by UCAS cycle. A UCAS cycle runs from September-August.
- Applicants applying for deferred entry is included. For example, someone who applied in 2012 could have applied for either 2012/13 or 2013/14 entry (deferred).
- We do not hold applications data prior to the 2012 UCAS cycle.
- All courses classified as “UG” in our systems have been included.
- An acceptance was taken to mean whether an applicant firmed their offer. We have included the most recent decision of an applicant. For example, an applicant would be included if they had a conditional insurance but later firmed us. Similarly, someone who had a conditional firm offer, but later declined, would not be included in the figures.

This completes the university’s response to your information request.

Your right to complain

If you are unhappy with the service you have received in relation to your information request or feel that it has not been properly handled you have the right to complain or request a review of our decision by contacting the Assistant Director of Business Assurance (Information Compliance) within 60 days of the date of this letter.
