## Request for Information - RFI20161667

Thank you for your request of 13<sup>th</sup> September 2016 under the Freedom of Information Act 2000 ('the Act') seeking the following information:

"On your application for a ARC TV Licence Question 2 of Section 4.5 states the following
"Dose the accommodation [sic] have any respite/short stay accommodation [sic] yes or no"

This is confusing as surely it should state guest rooms and respite rooms as these both come under entirely different legislation in the TV Licencing rules but are both short stay accommodation [sic], am i correct?

This i state as of the following reason

1st April 2007 1 respite room is included in a ARC TV Licence

The current TV Licence application clearly states under section 2.2 below Details of Carer the following is written

IMPORTANT NOTE: TV,s in communial [sic]rooms, GUEST ROOMS, and resident staff accommodation [sic] are NOT covered by the ARC Licence.

This is confusing when the application asks if you have short stay accommodation when clearly there are two different types of short stay accommodation [sic] one included in the ARC Licence and one not so i am asking

how you differentiate the two types when a application for a ARC TV licence is applied for as it asks for number of guest rooms but dose not ask for number of respite rooms?"

Please note that "TV Licensing" is a trade mark used by companies contracted by the BBC to administer the collection of television licence fees and enforcement of the television licensing system. The majority of the administration of TV Licensing is contracted to Capita Business Services Ltd ('Capita'). Over-the-counter services are provided by PayPoint plc ('PayPoint') in the UK, and by the Post Office in the Isle of Man and Channel Islands. Marketing and printing services are contracted to Proximity London Ltd. Media services are contracted to Media Planning Limited trading as Havas Media UK. The BBC is a public authority in respect of its television licensing functions and retains overall responsibility.

Please be advised that the Act gives a general right of access to all types of recorded information held by public authorities. We are not required to create new information to respond to a request, or give a judgement or opinion that is not already recorded. As this is a query rather than a request for recorded information, we are not obliged to provide you a response to your question.

However, in line with our duty to advise and assist you under section 16 of the Act, I am happy to inform you that the TV Licensing Customer Relations team will be able to assist you with your query.
