Dear Mael Ihamouchene,

Thank you for your recent enquiry we received on 17th February 2022 in which you asked for the following information:

Dear Forestry Commission,

Could you please provide me with statistics regarding the hectares or acres managed by the Forestry commission sold since 1970 (or if you don't possess the information up to that date, for as long as you can)?

I would also like information regarding the area acquired by the Forestry Commission for the same period of time.

We have considered your request under the Environmental Information Regulations 2004 (EIR) as the information you are seeking is considered "environmental information" as defined in Regulation 2 of the EIR. You can read more about the EIR here:

Please find our response to your request below:

When we acquire land, i.e. lease land to manage on behalf on the Forestry England estate, or sell land we own outright, this process is managed through deeds and leases. We do not have an overall database that compares how much land we have bough or sold since 1970 therefore in compliance to Regulation 12(4)(a) this

We do, however, have data of land that is been acquired and disposed of since 1991. While this does not show the change in the size of the estate, you may find of interest. Please find the export of data in a spreadsheet attached to our response email.

We can also confirm that we have no property up for sale on our estate at this time, this is line with the government's <u>commitment to ensuring that public</u> <u>forests are kept in trust for the nation with no net reduction in the size of the nation's forests.</u>

You may also find of interest Forestry Research's Forestry Statistics' publications, which does capture (in hectares) the size of the Forestry England estate. These publications go back until 2016 where a comparison of the size could be measured.
