**FREEDOM OF INFORMATION REQUEST REFERENCE NO: 945.2017-18**

I write in connection with your request for information which was received by North Yorkshire Police on 03 December 2017. I note you seek access to the following information:

*I am writing to request the number of arrests made in the past year (that is, December 2016 to December 2017) made by the force for the use of mobile phones whilst driving. I would also like to request the number of these people charged for the same period. If possible, I would like the figures presented per month.*

*In addition, if it is possible, I would like to request the number of those arrested taking photographs or recording videos on their mobile phones whilst driving out of the arrests made for the offence.*

**Extent and Result of Searches to Locate Information**

To locate the information relevant to your request searches were conducted within North Yorkshire Police.

I can confirm that the information you have requested is held by North Yorkshire Police.

**Decision**

I have today decided to disclose the located information to you.

Between December 2016 and December 2017 there have been 3 arrests for the offence of 'Use a handheld mobile phone / device while driving a motor vehicle on a road'. All 3 resulted in being charged with the offence.

The months were March, July and August.

None of the reports mentioned taking photos or recording videos.

Please note that systems used for recording information are not generic, nor are the procedures used locally in capturing the data. It should be noted therefore that this force's response to your questions should not be used for comparison purposes with any other responses you may receive.

## **COMPLAINT RIGHTS**

Are you unhappy with how your request has been handled or do you think the decision is incorrect?

You have the right to require the North Yorkshire Police to review their decision.

Prior to lodging a formal complaint you are welcome and encouraged to discuss the decision with the case officer that dealt with your request.

Ask to have the decision looked at again –

The quickest and easiest way to have the decision looked at again is to telephone the case officer that is nominated at the end of your decision letter.

That person will be able to discuss the decision, explain any issues and assist with any problems.

### **Complaint**

If you are dissatisfied with the handling procedures or the decision of the North Yorkshire Police made under the Freedom of Information Act 2000 (the Act) regarding access to information you can lodge a complaint with the North Yorkshire Police to have the decision reviewed. North Yorkshire Police must be notified of your intention to complain within 2 months of the date of its response to your Freedom of Information request. Complaints should be made in writing and addressed to:

In all possible circumstances the North Yorkshire Police will aim to respond to your complaint as soon as practicable but within 20 working days.

### **The Information Commissioner**

After lodging a complaint with North Yorkshire Police if you are still dissatisfied with the decision you may make application to the Information Commissioner for a decision on whether the request for information has been dealt with in accordance with the requirements of the Act.
