Dear Mrs Newsom

Thank you for your e-mail received on the 16 January 2018 requesting an internal review. I have been appointed as HSE's independent appeals officer in reviewing the case in accordance with our FOI & EIR appeals process.

In refusing your request as repeated Mrs Stevens stressed that no further material was held since the material provided to you in July. My internal review has focused on confirming that this is the case.

In August 2017 Janice Broad confirmed to you that it is not HSE's policy to request Licensed asbestos contractor clearance certificates and related plan of work and waste disposal records. In your internal review request you query how HSE can effectively regulate if the contractor is the only source of paperwork. The purpose of an internal review is to establish whether your disclosure request has been properly handled and not to open up discussion on how HSE operates as a regulator. These explain how asbestos licensing is a "permissioning regime" and HSE's role in the process.

As part of my internal review, I requested that a further search was undertaken to confirm there is no further additional material held. It has been confirmed that there is nothing further for the period July to November 2017. A further two notifications were received in January 2018 and I attach these for your information.

Given that a reasonable period had elapsed between your two requests, I am overturning the decision that your request was a manifestly unreasonable one because it was repeated. Your request should have been handled as a new request with an information not held response sent for the period July to November 2017.
