Further to your recent valued enquiry and our subsequent site visit, we have pleasure in submitting the following quotation.

**Scope of Works:**

**Clock Tower**

- Removal of all AIB debris and Full environmental clean of the clock tower
- Supply fixed scaffolding access
- 4 stage clearance test upon completion

**Back Stage**

- Under locally controlled conditions remove AIB panels 3Lm x 2
- Supply independent analyst to carry out ambient, back ground, personal and reassurance air monitoring, re instatement by others.

**Waste:**

- All asbestos waste to be disposed of to an Environmental Agency Special Waste Site, via sealed containers transported by a licensed carrier of hazardous waste, copies of Waste Consignment Note/s will be made available for your retention upon completion of the project.

**Air Monitoring:**

- All air monitoring to be carried out totally independent of us by a UKAS ISO 17025 accredited laboratories, copies of all air monitoring will be made available for your retention upon completion

**Programme:**

- We envisage these works taking approximately 4 days to complete, given full access and uninterrupted possession of the site.

**Exclusions:**

- We have made no allowance for reinstatement or making good within our tender.
- Minor damage to décor caused by construction of enclosures using tape, spray glue and staples (due to the nature of the adherent side of the tape there is a possibility of tape residues remaining on decorative surfaces, fixed appliances, flooring etc).
- Damage caused whilst accessing and removing asbestos materials; (e.g. within ceiling voids or to ceiling grids) however, operatives will cause minimum damage at all times.

**Cost:**

- A sum of **£4,569.00** Plus Vat.

**RIS Requirements:**

- Site welfare and storage facilities.
- Free supply of Electricity and Water for the area(s) of work.
- Unrestricted access to the area(s) of work.

**Conditions:**

- Additional costs encountered due to non-continuity of work through no fault of our own will be billed for.
- Retention monies held against our accounts will not be accepted. We are employed to remove materials from sites, and once completed, are issued with a certificate of completion that confirms the removal by an independent analytical company, therefore defects liabilities do not apply.
- Our tender may require adjusting should the Client implement a particular specification or working restrictions/requirements on this contract.
- Due to the nature of these works a statutory 14-day notification must be made to the HSE prior to works commencing. Please note that an official order number or written confirmation of your acceptance of our quotation is required prior to any liaison with the HSE. We will require a minimum of 2 working days to prepare this notification package.
- All operations shall be carried out in accordance with current legislation relating to the operations and any legislation or guidance notes relating to the treatment of asbestos.
- Detailed method statements and risk assessments will be provided upon award of contract and trust that our registration of BE EN ISO 9001:2000, 14001:2004 and 18001:1999 demonstrates that our works are carried out under a Quality Assurance System.
