Freedom of Information Act - Request for Information Our Reference: FOI 0105

Thank you for your Freedom of Information request received on 12 January 2016. You asked:

May I please see a copy of the current contract awarded to Maximus that covers fit for work assessments?

May I please see a copy of the last contract awarded to Atos for the same work?

In addition, will you please give full details in each case of the financial incentives or bonuses offered for the contract holder (Maximus) to assess a claimant as fit for work?

Who is Maximus' indemnity/public liability insurer, and was is the value of the policy?

In the search box complete only the fields 'date range' and 'house', please input 19/07/2014 in both the date fields. Select Lords from the House drop down menu. Click Go and then click on Dep2014-1173.zip from the list of search results. If you do not have access to the Internet at home, you may be able to use facilities at your local public library.

The versions of the contracts between the Department for Work and Pensions (DWP) and Maximus (Centre for Health and Disability Assessment Services) and between DWP and Atos Origin IT Services UK Limited (Atos Healthcare) placed in the public domain have had parts removed that contain information exempt under Sections 40(2) (third party personal information where disclosure would breach data protection principles) and 43 of the Freedom of Information Act 2000. When information is exempt under Section 43, this is due to commercial sensitivity.

Personal information about a third party is treated as exempt information under section 40(2) of the Freedom of Information (FoI) Act 2000. This is because access to personal information is treated under the provisions of the Data Protection Act 1998 and can only be released to you where such disclosure would not breach that person's right to privacy.

DWP maintains the following policy on disclosure of personal information:

"All personal information held in social security records is regarded as confidential. Information will not normally be disclosed to third parties without the consent of the person concerned. Information may normally be disclosed without consent to meet statutory requirements; to comply with a court order; to prevent duplication of payments from public funds; or where there is a compelling public interest in making the disclosure."

All disclosures made by DWP, in order to be considered authorised must be able to demonstrate that at least one of the above criteria apply. Any disclosure must have a sound legal footing and comply with the Data Protection Act 1998 Principles.

Under the Fol Act, DWP is not obliged to confirm or deny that it holds personal information about third parties, but in any event, even if was held, the Department would not disclose personal information to you.

Section 43 exempts information which, if disclosed, would be likely to prejudice the commercial interests of any person. It protects not only the commercial interests of third parties but also the commercial interests of the Department. It is intended to protect the ability of a public authority like DWP to obtain goods or services on the best possible commercial terms and to protect the legitimate commercial interests of its suppliers. The information you seek falls into this category.

As required by the FoI Act the use of this exemption requires the public interest for and against disclosure to be assessed. Generally speaking there is a public interest in the disclosure of commercial information to ensure transparency in the accountability of public funds and to show that public money is being used effectively. Conversely, there is a public interest in ensuring that disclosure does not compromise an existing competitive market environment or the Department's ability to secure best value for money for the taxpayer. On balance I am satisfied that, in this instance, the public interest in applying the exemption outweighs the public interest in disclosure.

There is no financial incentive for the contract holder to assess a claimant as fit for work.

Maximus' indemnity/public liability insurer and the value of the policy is exempt under Section 43 of the Freedom of Information Act, see above.
