	Adjustment Offers	<p>The August Reconsideration Pool (ARP) is a new process for the 2022 cycle. Previously, offers were made in August via UCAS Adjustment. The University of Cambridge used the Adjustment process from 2019 to 2021.</p> <p>Please note that the figures here show applicants who fulfilled all of the Adjustment eligibility criteria. These applicants met the contextual flags, UCAS Adjustment eligibility and achieved at least the typical Cambridge offer for the course they applied for.</p> <p>* <b>Law</b> was one of a number of courses not open at all at Cambridge for Adjustment in the 2020 and 2021 admissions cycles.</p> <p>** <b>Places</b> are not specifically reserved for Adjustment/ARP in any course. A decision on whether to open a course in Adjustment/ARP is made once we know how many offerholders have definitely met the conditions of their offer, and therefore how many places are available on the course.</p>
