Your request was received on 11 February 2020 and I am dealing with it under the terms of the Freedom of Information Act 2000 ('the Act').

You asked:

Please would you let me know what the average A*/8/9 grade counts and CSAT scores (if applicable) were for successful (i.e. accepted) applicants for Computer Science split up by individual college.

I would like to have this information for the last 4 admissions cycles.

The requested information, insofar as it is held, is attached. Information about CSAT scores is not held; this aspect of the application process is managed locally by each of the individual Colleges, each of which is a separate legal entity and public authority under the Act.
