10.4 Notes, general

whilst mobile and available on 6201 we were flagged down by a disabled bariatric lady on a mobility scooter. Her scooter had run out of power whilst overtaking a parked car. We manouvered the scooter to the kerb and contacted MACC. The lady was cold, had been stranded for over 30mins prior to our arrival, had no money for a disabled taxi, could not walk and had no relatives. After discussion with GM Speed an ambulance was called. An ambulance came and we assisted in removing her from the scooter into the ambulance.
