Response

It is likely that Birmingham City Council holds the information you have requested, however some parts of your request are very broad, for example 'what evidence and reasons in support will be used in those decisions'.

We have estimated that it will cost more than the appropriate limit to clarify if we hold everything you have requested, and to then provide it as the information is likely to be held across many systems. The Appropriate Limit is defined in the Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulations 2004 ("the Fees Regulations"). In the case of Local Authorities, including the council, the Appropriate Limit is £450 at a rate of £25 per hour, which equates to 18 hours.

If you were to narrow the scope of your request, for example by limiting it to records held since 1 April 2017, we may be able to comply with your request. Any reformulated request the department receives from you will be treated as a fresh FOI request.

Please note that some of the information you have requested is not covered by the Freedom of Information Act 2000 (the Act), as it is not held in recorded form.
