

You'll be aware from previous interactions on LCMs that the entire process can (depending on Assembly priorities) take anything up to 8/9 months to complete fully — and as things stand, this may mean it could be difficult to achieve within the lifespan of the current Assembly.

Perhaps we could speak on Monday to agree next steps?

Please accept my apologies for the delay in responding. Thank you for your email below.

We do not envisage that the SBC proposals would affect or amend any existing legislation. The SBC could have UK-wide territorial extent, but this is subject to each of the DAs confirming that the measures should extend to

Northern Ireland, Wales and Scotland. We believe a legislative consent motion from Northern Ireland requesting inclusion would be required if the decision is to apply the provisions to Northern Ireland. This is because we are proposing to provide support to businesses by establishing a statutory office holder, with functions to assist small businesses to avoid and resolve disputes with larger businesses, in relation to payment practices. It would be useful to have a view from your Departmental Solicitors.

Thank you for coordinating the input of other Departments. We are very interested to discuss any feedback you have on the proposals. Perhaps we can set up a call early next week to discuss? We are keen to work closely with you to establish whether the SBC measures should, in principle, extend to Northern Ireland, and whether the Northern Ireland Executive is content to support an LCM.

We spoke previously about the letter from Anna Soubry MP to FMdFM regarding the Discussion Paper on proposals for a Small Business Commissioner.

Since then we've had sight of a letter (attached) from Sajid Javid MP to the ETI Minister, Jonathan Bell MLA, which also makes reference to the SBCS proposal and its inclusion in the planned Enterprise Bill.

As you know were currently investigating which NI Departments (DETI included) may have an interest or role in those aspects of the Enterprise Bill which may require LCMs or similar actions on the part of the devolved administration here. The letter's Annex presents quite a broad range of proposals and the LCMs may be the responsibility of various Departments here.

Mr Javid's letter is very useful in setting out the various proposals for the Bill, and has very helpfully identified the areas of the proposals where an LCM is likely to be required for NI. A commitment is also given to writing to Minister Bell again once the position is clearer on the SBCS proposal.

Do you know if BIS is yet in a position to clarify what pieces of legislation (if any) are likely to be affected or amended by the SBCS proposal, once it becomes law?

At the moment, based on the discussion paper and our initial conversations with you, it seems that if the SBCS was established by the proposed Bill, it would have a UK-wide territorial extent, and no LCM would be required (subject to confirmation from BIS that no other pieces of legislation are amended or revoked and subject to advice from Departmental Solicitors). That would, in our opinion, be the most efficient approach as it would avoid unnecessary replication on our part, and it is in keeping with previous policy of maintaining parity between NI and GB law in relation to business.

I note that LCMs may be needed for other parts of the Enterprise Bill, and DETI will be forwarding the letter to the other NI Departments to allow them to determine whether they will need to bring forward any LCMs. We'll keep you informed if any other Departments express an interest.

From a policy point of view on the SBCS, we're awaiting a response from our Minister to Mr Javid's letter, and we'll keep you posted on the outcome of that as soon as we receive his comments/views.
