Release of Information

Thank you for your correspondence of 20 January 2019 in which you requested the following information:

- '1) The number of officers that have been commissioned into the royal navy that identify as Black (African)
- 2) The number of naval officers that identify as Black (African) that have successfully graduated from an operational conversion unit as pilots.
- 3) A breakdown of aircraft types that have been flown by officers that identify as Black (African), and the number that flew each type.'

And then clarified on 28 January 2019:

'With regards to the timeframe in which to provide information for: if possible, can you provide the current numbers for each of the questions, i.e. the number of currently serving naval officers that identify as Black (African) and have successfully graduated from an operational conversion unit as pilots; as well as seperately the total number in the history of Royal Navy (post 1960).'

Your enquiry is being treated as a request for information under the Freedom of Information Act 2000.

A search has now been completed within the Ministry of Defence and I can confirm that information in scope of your request is held and can be found detailed within Annex A.

I should advise you that ethnicity data is held from April 2007 and is self-reported on the Joint Personnel Administration system. Personnel may not, therefore, have an ethnicity

recorded or may choose not to declare, and the figures provided are for personnel with a known ethnicity that includes Black (African), this includes personnel with mixed ethnicities.

It may be helpful to note the response to questions two and three includes Pilots in the Royal Navy (RN) Warfare Fleet Air Arm (FAA) branch and Maintenance Test Pilots in the RN Engineer FAA branch.

If you have any queries regarding the content of this letter, please contact this office in the first instance.
