Your Request:

"I am requesting the following information under the FOI Act.

The number of Blue Badge misuse recorded in 2017/2018 and 2018/2019.
How many of these resulted in the vehicle being impounded?
How many of these resulted in a fine (separate from the parking ticket)?
How many were taken to Prosecution? "

Answer:

- a) The number of Blue Badge misuse recorded in the financial year 2017/2018 (April to March) was 1,186 and in the financial year 2018/2019 it was 1,353.
- b) 198 of these vehicle were impounded in the financial year 2017/2018 and 373 were impounded in the financial year 2018/2019

In relation to the third and fourth part of your request we do not hold information on the number of separate fines issued, nor the number taken to prosecution.

Given the information is not held by City Parking (Glasgow) LLP we are unable to comply with this part of your request under Section 17 of the Act.
