

THE COUNTY OF CAMBRIDGESHIRE
(NORTHERN HISTORIC CITY CENTRE, CAMBRIDGE)
(PEDESTRIAN ZONE AND PERIPHERAL STREETS)
VARIATION TRAFFIC ORDER 1995

The County of Cambridgeshire in exercise of the powers under Sections 1,2 and 4(2) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") as amended and of all other enabling powers after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act hereby make the following order;

1. The order shall come into operation on the 11th day of January 1996 and may be cited as "The County of Cambridgeshire (Northern Historic City Centre, Cambridge) (Pedestrian Zone and Peripheral Streets) Variation Traffic Order 1995".
2. For the purposes of this Order:

"public service vehicle" has the same meaning as in the Transport Act 1985.
3. Article 5 of the County of Cambridgeshire (Northern Historic City Centre, Cambridge) (Pedestrian Zone and Peripheral Streets) Order 1993 is hereby varied and shall have the effect as though for the words "Article 3 or Article 7." were substituted the words "Article 3 or Article 7 or Article 35.".
4. Article 6 of the County of Cambridgeshire (Northern Historic City Centre, Cambridge) (Pedestrian Zone and Peripheral Streets) Order 1993 is hereby varied and shall have the effect as though in part (iii) for the words "Article 3 or Article 7." were substituted the words "Article 3 or Article 7 or Article 35.".
5. Article 36 of the County of Cambridgeshire (Northern Historic City Centre, Cambridge) (Pedestrian Zone and Peripheral Streets) Order 1993 is hereby varied and shall have the effect as though the following words were added:

"(iii) a public service vehicle being used at any time by a zone permit holder for the provision of a free bus service and is travelling in a southerly direction.".
6. Schedule 3 to the County of Cambridgeshire (Northern Historic City Centre, Cambridge) (Pedestrian Zone and Peripheral Streets) Order 1993 is hereby varied and shall have the effect as though the aforementioned Schedule 3 were replaced by the following words:

"SCHEDULE 3 - NO THROUGH ROAD

POINTS IN ROAD BEYOND WHICH NO VEHICLES ARE PERMITTED IN ANY DIRECTION EXCEPT ZONE PERMIT HOLDERS VEHICLES TRAVELLING IN A SOUTHERLY DIRECTION AND PEDAL CYCLES PROCEEDING IN A CYCLE LANE


