Dear Ms Whittaker,

Thank you for your email of 20 February in which you requested the following information:

- "1) Please could I know the budget used per year since 2000 for your advertising campaigns.
- 2) The record of recruits who have said they joined due to your advertisements.
- 3) The target demographic
- 4) Which, if any regions are targeted more than others?
- 5) Which advertisement (print, online, radio, tv) has been recorded as most successful.
- 6) The record of the number of times your advert has been played on TV, by which broadcaster and which region."

I am treating your correspondence as a request for information under the Freedom of Information Act (FOIA) 2000 and I have therefore considered whether the Department holds any recorded information in respect to your request. I can confirm that MOD holds some information relating to your request and I have provided this below.

1) Not held. Under Section 16 (Advice and assistance), you may find it useful to know that although the budget since 2000 is not held, the actual expenditure for both marketing and advertising conducted under the Recruiting Partnering Project (which commenced in 2012) can be found in the following table. Please note that this expenditure is far wider than simply advertising campaigns:
