Your total scoring for experience, Methodology and Approach is 45%. A suggestion would be to split: 10% healthcare experience, 10% library experience, 10% Education, 15% methodology and approach.

I would like to see the tenderers provide a fee schedule against LIFT Approval stages or RIBA stages. This will help proportioning fees should the scheme get delayed at any point and also help in instructing on the initial feasibility stage.

The approach and methodology for the project in hand is the most important aspect and in many ways the experience shown from the bidders will manifest itself in their approach to the co-location project. Hence the scoring. I hope I've explained adequately.
