Looking at the OS/GIS and aerial photograph, there are two buildings side by side. The building which runs alongside the car park also has an outbuilding to the rear.

Prior to demolition, a Type 3 Asbestos Survey will need to be undertaken. This is an intrusive survey which should be undertaken immediately the building has been vacated but not before (without careful consideration). If the building is still in use and an asbestos survey is required urgently, a Type 2 survey (non-intrusive) will need to be undertaken. This can be followed at a later date by the Type 3 survey if necessary.
