Thanks for clarifying that. I can now see that this was detailed in an earlier email. In summary there are:

- 59 staff and thus we need to provide at least 6 racks (spaces for 6 bikes)
- 175 visitors thus we need to provide at least 18 racks (spaces for 18 bikes). These will need to be available to all building visitors.

As a reminder, BREEAM requires that the racks are:

- · The space is covered overhead and protected from the rain
- · The covered area and the cycle racks are set in or fixed to a permanent structure (building or hardstanding) and allow both the wheel and frame to be locked securely (e.g. Sheffield type). Or racks are located in a locked structure fixed to or part of a permanent structure with CCTV surveillance.
- · There is a minimum distance of 1.0m between cycle racks, where the racks allow for two-sided parking, and 0.8m for one-sided parking to enable bikes to be easily stored and accessed.

- · There is a minimum distance from any obstruction e.g. wall (located either to the side of the stand or in front of it) of 300mm for single-sided use and 900mm for double-sided use.
- \cdot Adequate lighting is provided in accordance with BS5489 Part 1 *Lighting of roads and amenity areas74*.
- · The facilities are in a prominent site location that is viewable from the building.
- · The majority of the cycle racks are within 100m of a building entrance (ideally within 50m).

The current plans look good and at this stage we have could afford to lose two racks from the staff spaces (leaving the required 6 for BREEAM) and only have nine racks at the car park (18 spaces).

[section40(2) – FOIA] has previously stated that in terms of the children, only students who are able to ride a bike should be considered within the 'building users'. Therefore, I believe we can omit all of the children from the count.

We are therefore left with approximately 37 visitors for the health centre and 33 visitors for the library at any one time. This equals 70 visitors at 10% = 7 cycle spaces.

I agree we need approximately 6 for staff.

Therefore, the total number of cycle racks required is 6 staff and 7 visitor. If you want to provide a few spaces for parents who may wish to wait for children then I would suggest approx 2 spaces, although this is not based on standards.

The calculation for the number of racks was discussed at length back in March. [section40(2) – FOIA] requested it to be based on 10% of staff and 10% of building users at any one time (for the first 500).

For staff we have 59 / 10 = 6 cycle spaces.

For users, I would omit the 2/3 years old children and children from the children centre (supposed to be 0/3 years old kids) as well as PMLD children.

Therefore, in terms of children we are left with 50 x 3/5 years old and 5 x ASD in acorn.

For adults, we have: 60 in library, 60 in waiting, 17 in health centre, 22 in children centre (including interview), 10 in parents room and say 6 in pharmacy with a total of 175.

According to the above, grand total for users is 230 of which 10% give us 23 racks. I would provide 5 in the children play area (because of the size of children bikes which require special racks or be scooter rack).

We are then left with the 6 cycle spaces for staff (we show 8 on our plans) and 18 cycle spaces for users (we show 20 at the bottom of the ramp near the carpark and 10 near the "Acorn entrance").

We can therefore lose one stand for staff to provide the 6 spaces required, omit the stands near the "Acorn entrance" all together and keep 9 stands (= 18 cycle spaces) near the carpark.

This would reduce the requirement for a large canopy next to the "Acorn entrance" (normal door canopy for DDA still required).

Can you all please assess and comment before we revise the plans.
