ITEM ACTION

BP DESIGN REVIEW 1

- This was the follow-up consultation with [section 40(2) FOIA] from the Children's 1.1 Centre/Nursery because [section 40(2) – FOIA] missed the Stakeholder 3 Consultation session.
- 1.2 2 - 3 year old room needs some separation between toilets and larger nursery room. Do not want a solid block wall but need barrier.
- 1.3 Toilet provision is okay, need a nappy changing area in the hygiene room
- 1.4 Storage for nappies: Little rack seen at Effra would be good in the toilet.
- 1.5 Glass walls good leading to outside space.
- 1.6 Wet area - child and adult level sinks.
- 1.7 All areas that needs sinks - wet area, paint area. Will start thinking about this.

ITEM ACTION

2 CHILDREN'S CENTRE

2.1 When partition is closed will need to be able to use sanitary area (which is children and adult toilet). Need access to an adult toilet - issue visitor swipe card is fine.

- 2.2 Like the cupboards but do not need them to be that deep. Fixed storage in adult reaching distance only beyond that, will not be used. [section 40(2) FOIA] asked [section 40(2) FOIA] to speak to [section 40(2) FOIA] about how they use the higher up cupboards.
- 2.3 Big open storage closet this is the storage space on opposite side from nursery hall.
- 2.4 Shared meeting and storage across the hall. See that room as the primary 'training room' the across the hall storage will be for plinths and chairs, etc. for multipurpose functions.
- 2.5 Adult changing convert into DDA toilet with shower and table. [section 40(2) FOIA] to send through.
- 2.6 Can three offices have a link between three?
- 2.7 A small space to work with children in a quiet way. [section 40(2) FOIA] will have to find a balance between storage and finding one to one space in room. Don't need a second door, so could create a small space there and storage cupboards could run along the wall up to the other door and along the rest of the wall on the other side of the 1:1 room. Room does not need to be a completely isolated space.
- 2.8 Dining space could also be used for separate space. Will be used for breakfast, lunch and tea. Rest of the day a space between AA and Nursery. Low-level barrier rather than completely open.
- 2.9 Move entrance into 3-5 nursery so it opens onto dining.
- 2.10 CC storage across hall one side toy library and one-side resources.
- 2.11 Outside space between 3-5, 2-3 and children's centre gate separate but can be opened to share. 2-3 needs much smaller space compared to 3-5 nursery. CC space does not need to be huge either. CC is smaller square, 2-3 square and wraps around the back of the CC play area but gates link the two.
- 2.12 Will need acoustics similar to Effra in ceiling?
- 2.13 [section 40(2) FOIA] start looking into furniture requirements particularly the coat racks etc., so the dimensions can be worked into the room. Would be better to have 100 pegs but could share if they have two shelves underneath.
