## **FREEDOM OF INFORMATION ACT 2000**

Thank you for your following request to FOI request reference 79230 made via the What Do They Know website on 4<sup>th</sup> February 2020 in which you state the following:

We have the 2 machines serviced yearly by Dantec Dynamics, which is under contract. For formal paper records and manufacture details you would need to contact Dantec Dynamics direct who supply and service our machines."

I have had no luck in the past getting a response from Dantec Dynamics myself as they do not have a relationship with me.

Could I please request that you reach out to Dantec that you have a contract with in order to source the maintenance records for the ECT machines that you manage and operate so that you can supply these records to me?

In response the Freedom of Information Act 2000 provides public access to information held by public authorities. Your request asks us to obtain information we do not hold and this is detailed in our formal response (79230) to your original request and as such is outside of the scope of the Freedom of Information Act 2000.

Whilst we appreciate that you have an interest in obtaining this information it would not be an appropriate or efficient use of public resources for us to attempt to obtain the information you require from Dantec Dynamics.
