REQUEST UNDER THE FREEDOM OF INFORMATION ACT 2000

Further to your enquiry, which we received on 19 February 2014, you requested the following information:

I would be grateful if you could provide me with the following information:

The total number of call-outs in Herefordshire between February 1 2012 and February 1 2014 to deal with an incident where the primary problem was alcohol intoxication.

Please could the information be broken down by month and specifically include the total number of call-outs to deal with alcohol intoxication on December 24/25/26 and 31 for both years.

Many thanks for your help and time.

Response

Unfortunately, we are not able to provide this information for a number of reasons;

- 1. When a 999 call is received, it is categorised for the reason for the call but unfortunately, alcohol is not one of them, it can be categorised as an "overdose" which may also include drug overdoses.
- 2. When a crew arrive on scene to treat a patient, if they feel alcohol is "suspected" there is a box that they tick on the patient report form. However, this is only "suspected". From August 2011 the Trust had experienced issues with the quality of data stored within our clinical data systems. A sample of these records were manually validated and this showed that the quality of the data was poor therefore we are unable to provide a true figure from our current system for the time period specified in your request. This was due to software issues which were rectified in May this year but we are unfortunately unable to retrospectively rectify this data.
- 3. The reporting system used for the patient report form data is unable to provide the information by area specifically. The call signs of the attending vehicle are also a unreliable way of locating this information as a Herefordshire crew may have attended an out of area incident and likewise with an out of area crew

attending an incident in Herefordshire depending on the operational demands on the Trust at the time.

We hope that this answers your request. If you are dissatisfied with our response you have the right to appeal in line with guidance from the Information Commissioner:
