Your request ref: **035_1920** has been dealt with under the Freedom of Information Act 2000.

You asked us:

Could you please provide me with the number of call outs to emergencies that each station in the south wales fire service responded to in the year of 2018 (including automatic alarm callouts)

Our response:

Incidents are counted once for each station from which one or more appliance has been recorded on-scene (excludes re-attendances and multiple appliances from the same station to the same incident). However, as more than one station may have attended an incident, overall totals do not equate to incidents attended by SWFRS as one incident may be counted against multiple stations.

Report excludes additional specialist or support appliances.

Data includes all incidents categorised as Fire, Special Service Call and False Alarm.
