Dear Mr Grigore,

Your request was received on 23 February 2016 and I am dealing with it under the terms of the Freedom of Information Act 2000 ('the Act').

You asked:

I am writing to kindly request the following information under the Freedom of Information Act 2000 regarding admissions to the BA Law course (M100):

- 1. The predicted and achieved International Baccalaureate Diploma grades, with their corresponding subjects and bonus points, for each individual given an interview invitation for the BA Law course (M100) during the admissions cycles between 2013 and 2015;*
- 2. The final offer status (Offer, No Offer) for each application receiving an interview;*
- 3. The Colleges applied to, given interviews, and given offers (if given) from, for all interview invitation and offer holders;*
- 4. The conditional offer requirements for each of the offers, or if the offers were given unconditionally;*
- 5. The date of the submission of each application by interview holders;*
- 6. The country of origin of the individuals referred in question 1;*
- 7. The school of origin of the individuals referred to in question 1;*
- 8. The Cambridge Law Test score for each individual referred to in question 1;*
- 9. Interview scores for each individual referred to in question 1;*
- 9. Information on any possible qualitative or quantitative marking scheme used to assess the Cambridge Law Test;*
- 10. Information on any possible qualitative or quantitative marking scheme used to assess the interviews.*

The University does not hold any of the information requested. The premise of your questions is that we know which applicants were interviewed and what processes were followed in those interviews.

Please note that all of these Colleges admit to undergraduate degree courses apart from Clare Hall and Darwin College.

Generally, the Information Commissioner cannot make a decision unless you have exhausted the complaints procedure provided by the University.
