- 3. Please also advise if the College being the procurement authority, have to report directly to the SFC the detail of any/all spends of the funding awarded for various reasons including but not limited to audit purposes, as The Scottish Funding Council has a role in ensuring the college sector as a whole keeps within Scottish Government budgeting requirements.*
- 4. Please advise if this funding allocation of £16.5, made by the SFC to the City of Glasgow College for the purpose of the NPD New Build Campuses is considered/noted for accounting practice as 'revenue' funding or 'capital funding'?*


