Freedom of Information Request

Thank you for your email dated 20 December 2022 addressed to the Leicester, Leicestershire and Rutland Integrated Care Board (ICB) in respect of your request for information under the Freedom of Information Act 2000. The LLR ICB confirm our response below (your request is set out in italics for ease of reference).

- 1) Please provide the names of all CQC registered residential, nursing and supported living providers currently commissioned by the ICB to meet the needs of adults with learning disabilities and epilepsy.*
- 2) For each provider, please specify the number of placements currently funded through NHS Continuing Healthcare.*

If it is not reasonably practical for you to provide this information for learning disabilities and epilepsy, please apply the wider category of learning disabilities in fulfilling this request.

Response to Questions 1. – 2.: Please find the requested information detailed within the enclosed document, 'FOI Response - W20122022LLR.' Please note that the data includes the following information relating to adults with a diagnosis of learning disabilities:

Unfortunately, Leicester, Leicestershire and Rutland Integrated Care Board (ICB) is unable to provide the information you requested regarding Epilepsy and are engaging the exemption of section 12 (1) in the Freedom of Information Act 2000.

- This would not only require the time of the administrative staff but would require a (a Clinician perhaps) to be taken away from his/her duties to look through these notes.
