Response:

The Freedom of Information Act 2000 ("the FOIA") provides a right of access, subject to specified exemptions, to recorded information held by a public authority. In the case of the House of Lords, the rights of access apply to recorded information held by the House of Lords Administration.

The House Administration holds some of the information you have requested.

Can you please let me have a copy of any log/comments book or similar which allows
customers and or staff/visitors to register comments about food and drink they receive at any
outlet (bars, restaurants, shops catering services) in the House of Lords for the most recent 12month period.

The House Administration does not hold this information. We do not have a log or comments book for customers or visitors to register comments about catering services.

As questions 2, 3 and 4 are similar and encompass some overlap, we have grouped these questions together.

As the published information is considered reasonably accessible by means other than making an FOI request, it is exempt from disclosure under section 21 of the FOIA.

Please note that while some of the published information comprises complaints, the previous FOI responses also include correspondence which would be better described as making comments or recommendations rather than complaints.

In addition to the published information, we hold a record of two further complaints sent to the Chair of the Services Committee, along with the Chair's responses. Please find copies attached (documents *FOI 3296 (1)* and *FOI 3296 (2)*).

We have redacted some personal information from the copies, relating to the names and direct contact details of the individuals who sent the correspondence. This information constitutes third party personal data within the provisions of the General Data Protection Regulation (the "GDPR"), supplemented by the Data Protection Act 2018 ("the DPA").

We consider that disclosure of this information would breach data protection principle (a) (i.e. that data "should be processed lawfully, fairly and in a transparent manner in relation to the data subject"). These individuals would not have a reasonable expectation that their personal information in this context would be disclosed as part of an FOI response. We consider that this information is exempt under section 40(2) of the FOIA.
